

## **Crookwell 3 Wind Farm**

### **Project Status**

- ✓ All the components (blades, nacelles, hubs and rotors) have arrived and are being stored at Port Kembla.
- ✓ Construction estimated to begin at Q4 of 2022.
- ✓ Internal site roads and hardstands preparation works to begin 15 November.
- ✓ Increase of truck traffic on Goulburn end of Woodhouselee Rd & Graywood Siding Rd from 16 Jan 2023

#### **Under Progress:**

- ✓ Graywood Siding Rd— Works well advanced. Second crew starting November.
- Native vegetation and culturally sensitive sites are fenced and protected. Continual investigation is completed as works progress.

#### **Construction Work Hours**

Civil construction works will begin on Graywood Siding Road on the 19<sup>th</sup> September 2022, and is expected to take three months to complete, weather permitting. Works will occur during standard construction hours of work:

- Monday to Friday, 7am to 5pm
- Saturday, 8am to 1pm



**Stop/Go lights** will be **in operation on Woodhouselee Rd** for the beginning of the works, with Local access for vehicles to be provided at all times on Graywood Siding Rd.

### Local wildflowers in your backyard...



Working with Ecology Consulting, located in Crookwell, has been great own exploring our backyard. I mentioned the September newsletter that we complete preclearance of native flora and fauna before any construction works are started. As you can see from this photo to my left one paddock is exotic pasture for stock and in contrast is a native bush paddock wild with native plants and most likely animals. While completing the pre-clearance we had a great time exploring this bush paddock and seeing the local native plants our shire has to offer. Seeds from these plants are collected at the right time to replace any native areas damaged during construction.

The next photo to the right is a native grass paddock abloom with local native wildflowers. Have you been in your native bush paddock lately? Have look at the abundance of native flora this season has given us. Here is a few Finbar from Ecology Consulting has identified for you. Why not take the kids for a wander. 
