TransGrid will start the upgrade works of the current substation by the end of December.



Earthworks begin on wind farm

Activities on siteGraywood Siding Rd

- Maintaining of erosion and sediment controls
- Treatment of soft spots
- Complete trim batters
- Complete subgrade road base
- Roadside drainage clean of unsuitable material and install of drainage layer rock
- Install culverts

Wind Farm

- Clearing of understorey vegetation and preparation for hollow bearing tree treatment
- Fencing of sensitive Aboriginal Heritage areas
- Stripping of topsoil

Construction Work Hours

Civil construction works will begin on Graywood Siding Road on the 19th September 2022 and is expected to take three months to complete, weather permitting. Works will occur during standard construction hours of work:

- Monday to Friday, 7am to 5pm
- Saturday, 8am to 1pm



Stop/Go lights will be **in operation on Woodhouselee Rd** for the beginning of the works, with Local access for vehicles to be provided at all times on Graywood Siding Rd.
