Golden Plains Shire Berrybank Wind Farm Grants

The 2024 round of Berrybank Wind Farm Community Grants has been awarded to five community groups who will share in a combined \$65,245 over the next three years to help deliver a range of community projects and events.

The funding was available across two categories: Economic Development Projects and Tourism Projects, with one year and multi-year funding available for each category. The successful community projects and events included:

- **Inverleigh Dachshund Derby** – \$14,908 total to be delivered over the next three years to support this popular community event.
- **Dereel and Surrounding Communities Men's Shed Inc** – \$10,000 over the next three years for the 'Community Bonfire' event.
- **Meredith History Interest Group** – \$12,397 to support the 'Bursting at the Seams!' initiative.
- **Inverleigh Golf Club Inc.** – \$16,740 for the Inverleigh Disc Golf Course expansion.
- **Turtle Bend Events Committee** – \$11,200 to support the Live@Turtle Bend/Spring Solstice events.

Voluntary Agreement Part 2

Voluntary Agreements for Berrybank 2 Wind Farm have been finalised and will increase the funding pool for the Berrybank Wind Farm grants with both Corangamite and Golden Plains Shire. These Voluntary Agreements will take effect in the 2024 grant round.
