9.1 GPG Project Update

1. Project update - wind farm GPG




- ✓ Excavation has commenced on 8 turbine sites
- ✓ The site compound has been completed
- ✓ CFA conducted fire awareness and response training
- ✓ CFA have attended a site awareness session representatives were present from local brigades
- ✓ Temporary and permanent fencing continues
- ✓ Wash down bays installed for vehicles entering the site at designated points to meet bio security controls
- ✓ Access tracks are being constructed through the first section of the wind
- ✓ First turbine foundation scheduled for May, blinding and foundation preparation will occur earlier



- ✓ Speed restriction signs are being installed either side of the wind farm entrance. Temporarily 60 kmh, permanent speed restrictions of 80 kmh will be installed in the coming weeks.
- ✓ HDWF traffic restricted roads are sign posted
- ✓ Surveying and preparation for the southern entry has commenced
- ✓ Anchor cages and foundation components are arriving on site
- ✓ Construction work was halted on Friday February 24 due to the Total Fire Ban day
 - The temporary 60km per hour signs have been removed.
 - The 80km speed restriction that is now in place on the Woolsthorpe-Heywood Rd either side of the site entrance will remain until construction is completed. VicRoads required the speed limit to be included in the endorsed Traffic Management Plan (TMP). It was noted that a similar 80km speed limit was put in place during construction of the Mortlake Power Station. GPG can follow up with VicRoads for the reason it required the 80km speed restriction.
 - The green flag bunting marks areas of native vegetation.
 - On Total Fire Ban days, critical timed work such as concrete pours may be carried out.







- Around 700 cubic metres of concrete is required for each foundation pour.
- There are two foundation designs, one for clay and one for rocky ground.
- Each foundation is around 3 metres deep and 30 metres in diameter. Each batch of concrete is tested before it is poured.
- It is not expected that blasting will be required for foundation excavation.
- Each foundation is stabilised with reo and concrete. The foundation, backfilling and the weight of the erected turbine provides the stability.
- GPG can present a video of the process at the next CEC meeting.
- GPG noted that at the Berrybank Wind Farm, one foundation was removed after a fault was detected. The foundation will be re-poured.
- GPG will provide information on why the foundations won't be removed when the wind farm is being decommissioned.
- GPG will provide information on whether the foundations are engineered to Australian Standards.

2. Work hours



- Civil construction earthworks have now commenced to construct the access tracks and hardstands. Generally, the civil contractor will be working:
 - ✓ Monday to Friday 7am to 6pm
 - ✓ Saturday 7am to 4pm (regular)
 - ✓ Sunday & Public holidays 7am to 4pm (occasional as required)
- Saturday afternoon (1pm to 4pm) and Sunday works will be restricted to "managed impact" and "low impact" works as defined by the EPA guidelines.
- The purpose of weekend work is to reduce the overall construction duration, and subsequently the duration of impact on the local community.

- GPG has spoken with the Acting Principal of Hawkesdale College who has not seen any investigative papers, professional development or conversations in his education department networks on the topic of impacts on special needs students. If it is raised in the future he will let GPG know.
 - GPG will also engage with the Infant Welfare Centre and the Kindergarten regarding this.
 - GPG requested that if a CEC member finds a paper published on this topic to please pass it on to them.
- Arrangements have been made with Hawkesdale College to include the lead contractor's contact details in the communications list in the event of a school bus breakdown. A procedure has been put in place in consultation with the College.
- GPG provided the following table from the Shadow Flicker Analysis undertaken by DNV.GL in 2015 for the previous 26-turbine layout.

- - Turbines A10, A13 and A17 were subsequently removed due to the prediction that the shadow flicker limit would be exceeded at those locations. GPG will follow up with Liana regarding her request for the predicted shadow
 - flicker level for residence 53 (for the approved layout). GPG can provide a copy of the current shadow flicker assessment.
 - Copies of the BAMP will be provided to the CEC once the Minister endorses it, and it will be placed on the project website.
 - The project website will not include a link to Council's wind farm complaints handling web page. GPG noted it is important that it meets the requirements of the endorsed Complaints Investigation and Response Plan and maintains a clear



and consistent message to the public on all of its processes, whilst ensuring separation from the Council process.

- John asked how many people from within 15km of Hawkesdale are employed on the site. GPG did not have this information at hand, noting that local people wishing to enquire about employment can contact GPG directly and attend the Open Day next week to speak with contractors.

Benefit sharing

- ✓ Community benefit funds
 - Hawkesdale township from construction
 - Broader district 1 year after operation Application for membership to the Community benefit fund Committee is being finalised
 - Guidelines for eligibility for fund recipients to be finalised
- Anne-Maree reported there is some confusion in the local community regarding engagement with community groups and the community benefit fund committee membership model.



GPG noted it had informed several community groups that they would be eligible to nominate for fund committee membership, but the guidelines and selection criteria are not yet finalised. In the meantime GPG is compiling a list of community organisations and will arange meetings as soon as possible. The selection criteria proposed by GPG will include where a nominee lives and their age group so that there is a broad cross section of representatives. GPG proposes that CEC members would not be eligible for fund committee membership, and that there will be 6 community representative positions available. GPG will have 2 members on the committee.

GPG will consider the suggestion to invite HADDAC to have a representative on the fund committee.

10.1 Council provided a summary of the range of wind farm community fund models that exist or are proposed throughout Moyne. Most recently, companies have established or are proposing to establish local committees to consider fund applications. One project fund does not have a formal fund committee whilst another has an informal local consultation process in place. The annual fund amounts also differs across projects.



Permits do not include reference to community benefit funds. There is no apparent industry standard for wind farm community funds.
